

PRIVACY POLICY

Dryfast UK attaches great importance to the protection of your personal data. In this privacy statement, we want to provide clear and transparent information about how we handle your personal data. We make every effort to safeguard your privacy and will therefore handle personal data with care. Dryfast UK complies in all cases with the applicable laws and regulations, including the General Data Protection Regulation (GDPR).

Processing of your personal data

Dryfast collects and processes the following types of personal data:

- First and last name
- Gender
- Date of birth
- Place of birth
- Address
- Telephone number
- E-mail

With what purpose and on what basis we process personal data

Dryfast processes your personal data for the following purposes:

- Processing your payment
- Sending you our newsletter and/or advertising brochure
- Contacting you by phone or e-mail to perform our service, if necessary
- Informing you about changes to our service and products.
- To deliver goods and services to you

Special and/or sensitive personal data we process

Although our website and services are not generally aimed at children under the age of 16, it is Dryfast's policy to comply with legislation where it requires the permission of a parent or guardian before collecting, using or disclosing information relating to children.

However, we cannot control whether a visitor to our site is under 16. We therefore recommend that parents take an active role in monitoring their children's online activities. If you believe that we have collected personal data from someone under the age of 16, please contact us at info@dryfast.uk, and we will then delete the data.

How long we keep personal data

Dryfast keeps your personal data no longer than is necessary for the purpose for which it is provided, which is required by law.

Sharing of personal data with third parties

Dryfast will not sell your data to third parties, and will only provide them if this is necessary for the performance of our agreement with you, or to comply with legal obligations.

Cookies or comparable techniques

Dryfast only uses technical, functional and analytical cookies that do not violate your privacy. A cookie is a small text file that is saved on your computer, tablet or smartphone when you first visit our site. The cookies we use are essential for the technical operation of the site and for your convenience. For example, they enable the website to function and remember your preferences.

They also enable us to optimize our website. You can refuse cookies by setting your browser to the setting that does not save cookies. You can also delete any information previously saved in your browser.

Consult, adapt or delete your data

You have the right to access your own personal data. You can request, view and, if necessary, modify your personal data. In certain cases and on reasonable grounds, you may ask us to delete your personal data.

To make use of these rights, please contact us by following the procedure at the bottom of the page (Request for personal data).

Data can only be deleted if your relationship with Dryfast is terminated. If you are a customer or supplier, you cannot ask for data to be deleted if this data appears to be necessary for our collaboration or if there are reasons for keeping data such as legal disputes, unpaid invoices,.... In such cases, we will inform you.

Protection

Dryfast takes the protection of your data very seriously and takes appropriate measures to prevent misuse, loss and unauthorized access, publication or modification.
